All Independent Non-Executive Directors are independent of management duties and they do not have any family relationship with any of the other Board members which could interfere with their exercise of independent judgement during the decision-making process of the Board or the ability to act in the best interest of the Company and its shareholders.</p>

<b>Explanation on adoption of the practice</b>	:	<p>The Board has adopted the policy that the tenure of an Independent Director shall not exceed a cumulative term of nine (9) years.</p> <p>However, an Independent Director may continue to serve the Board upon reaching the 9-year limit subject to the Independent Director's re-designation as a Non-Independent Non-Executive Director.</p> <p>In the event the Board intends to retain the Director as Independent after the latter has served a cumulative term of nine (9) years, the Board must justify the decision and seek shareholders' approval at general meeting.</p> <p>In justifying the decision, the Nomination and Remuneration Committees is entrusted to assess the candidate's suitability to continue as an Independent Non-Executive Director based on the criteria on independence and the candidate's performance.</p>

All the retiring Director will abstain from deliberations and decisions on their own eligibility to stand for re-election at the Board Meeting.</p> <p>With the current composition, the NRC opines that all the Board members have the necessary knowledge, experience, requisite range of skills and competence to enable them to discharge their duties and responsibilities effectively. All Directors on the Board have extensive experience with their many years of experience on the Boards of other companies and/or also as professionals in their respective fields of expertise.</p>

Currently the Non-Executive Directors are paid Director's fees and attendance allowance for Board/General Meetings they attended.</p> <p>The Company's remuneration policy for Directors is formulated to attract and retain individuals of the necessary calibre relevant to the achievement of the Company's strategic objectives. The remuneration is structured to link experience, expertise and level of responsibility undertaken by the Directors.</p> <p>The Nomination and Remuneration Committee is entrusted with the responsibilities to make recommendations on the remuneration package for the Executive Directors to the Board. It is the ultimate responsibility of the entire Board to approve the remuneration of these Directors. Non-Executive Directors' remuneration will be decided by the Board as a whole with the Director concerned abstaining from deliberation and voting on decisions in respect of his individual remuneration.</p>
